You **MUST** have at least one document from **EACH** of the following three columns as proof of residency

Emergency Arrangements:

1. Custody papers / Notarized Caregiver Affidavit from Commonwealth of MA (used when a guardian assigns educational decisions to another person)
2. Notarized statement (original copy), signed by the Mansfield Resident, attesting to the fact that the student is sleeping in Mansfield (only in emergency cases where Affidavit cannot be provided.)
3. Mansfield residents providing emergency arrangements for students are required to prove their own residency in the Town of Mansfield as referenced above.
