Child and/or parent/guardian also specifically acknowledges and accepts the risk of travelling in their own vehicle, and acknowledges that they will maintain adequate automobile insurance to cover risks associated with said travel and to be responsible for any risks arising from said travel.

Furthermore, I/We acknowledge that I/We are aware that by signing up to participate in the Field Trip, that the Field Trip may not occur due to COVID-19. I/We further acknowledge that Mansfield cannot eliminate the risk of the Field Trip being cancelled due to COVID-19 and that by signing this CONSENT, RELEASE FROM LIABILITY AND INDEMNITY AGREEMENT, I/We fully and knowingly agree to ASSUME ALL RISKS associated with signing up for the Field Trip, including the possibility that the Field Trip may be cancelled due to COVID-19. In the event that the Field Trip is cancelled due to COVID-19, Mansfield shall not be responsible for any loss of monies paid by the Parent/Guardian or Student and the signatories agree that the RELEASE FROM LIABILITY shall expressly release Mansfield from having to pay or refund any monies paid for a Field Trip.
